Ms. Stratton,

Over the past several weeks you have been sending notices, orders, motions, and other pleadings to my facsimile number unannounced and without also sending a copy by mail.

Under your own Merit System regulations, you are required to mail all notices and legal pleadings to me.

Therefore, this is a formal demand that all those documents which have previously been sent via facsimile that were not mailed, be immediately mailed to me at the above address. Furthermore, all future pleadings and legal correspondence should be mailed as required by rule and statute.

Additionally, it came to my attention that there were a number of motions and pleadings filed by the County Attorney's Office in this matter that were not sent to me or were improperly addressed. With that in mind, and to ensure the integrity of the proceedings before the Commission, please send me a detailed docket/index of this case. It should include all those items contained in your case file, including the filing date and description of each document. If you fail to provide such, it will be deemed a deliberate act of obstruction of justice in this matter and action will be taken against you and your office accordingly.

Lastly, there are the matters of disclosure of candidate information and information concerning the Hearing Officer.

Per your own regulations, I am entitled to a disclosure of information concerning the candidates for the position in question, the description/requirements of the job in question, all modifications to any such job description/requirements, and the final selection of an employee. All of this was previously requested but none has been provided.

As for the Hearing Officer, again your own regulations provide for a disclosure of the Hearing Officer's background, the selection process, and all information/documentation concerning the selection and appointment of such. A request for such was previously submitted but nothing has been received.

Please immediately provide a full and detailed disclosure of all information concerning these issues pursuant to law. If the above has not been fully complied with within ten days of receiving this letter, appropriate civil and criminal action will be initiated against you and your office accordingly.
